# Our Goal: A Universal Standard for Every Learner

“

To guarantee, by adoption and practice, inclusive and equitable quality education and lifelong learning opportunities for all by 2074, such that every learner—irrespective of age, sex, disability, location, income, migration status, or cultural identity—can access safe learning environments; complete relevant levels of education; achieve minimum proficiency in literacy, numeracy, and digital skills; transition into decent work and civic life; and participate in continuous learning across formal, non-formal, and informal settings.”

# Defining Our Core Concepts



## Educational Equity

**Definition:** Equality of rights, opportunities, support, and outcomes across all learners.

**Key Actions:** Includes targeted measures to remove structural barriers affecting vulnerable populations and ensuring safe, non-violent, inclusive environments.



## Lifelong Learning

**Definition:** An integrated ecosystem spanning the lifespan—from early childhood through adulthood.

**Key Actions:** Links formal, non-formal, and informal learning, and enables reskilling and upskilling in response to societal, technological, and climate dynamics.

*These definitions are harmonized with SDG 4 targets and UNESCO's lifelong learning doctrine.*

# The Triple Imperative: Our Foundation for Action

The **rationale** for SGG 4 rests on three interlocking dimensions, positioning education as both an intrinsic right and an instrumental condition for achieving the vision of Agenda 2074.

## 1. Human Rights

A fundamental right affirmed by Article 26 of the Universal Declaration of Human Rights.

Denial of access perpetuates structural inequality.

## 2. Economic Empowerment

A primary driver of economic mobility, innovation, and poverty reduction.

A prerequisite for the "skills revolution" envisioned by Agenda 2063.

## 3. Societal Adaptability

Essential for resilience in the face of technological disruption, climate change, and demographic shifts. Enables continuous reskilling and upskilling.

Advocate for universal access to digital learning, gender-sensitive AI, and privacy protections.






