SGG 6 recognizes that disasters are not abstract possibilities but lived realities. When systems fail, people bear the weight. This goal seeks to ensure every community has the knowledge, structures, and social bonds to prepare, respond, and rebuild—moving from reactive crisis management to proactive resilience building.



In a world of increasing shocks, resilience is a social and economic imperative.

Prepared communities recover faster, suffer less harm, and protect the most vulnerable. Unpreparedness fractures social bonds and deepens poverty.



Driving Stability

Resilience protects jobs, maintains education, and safeguards health services during crises, creating a foundation for all other Social Global Goals.



Fostering Foresight & Solidarity

We must shift from reactive crisis management to **proactive risk governance**, where preparedness is a permanent feature of social systems, not just an emergency measure.

Our Goal: Every community with the capacity to anticipate, withstand, and recover from disasters by 2074.

Goal Statement: Inter Semi-Bold

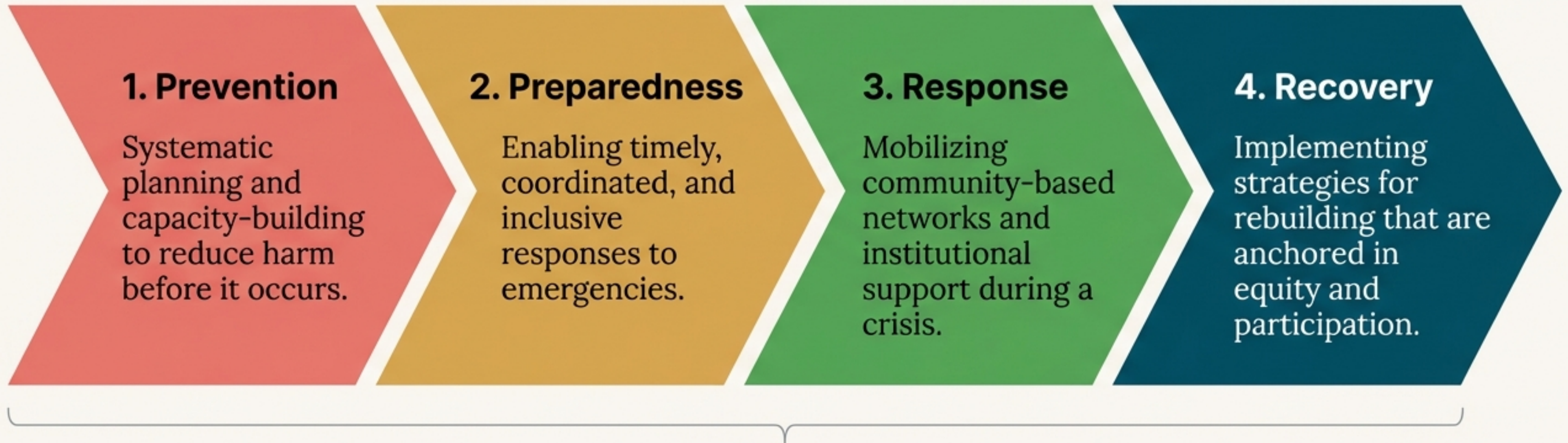
To guarantee, by adoption and practice, that every community has the capacity to anticipate, withstand, and recover from disasters and disruptions by 2074. This includes integrated early-warning systems, inclusive preparedness plans, community-based response networks, and recovery strategies that prioritize equity and dignity.

Key Definition in Inter Semi-Bold

“Community resilience” is the collective ability to absorb shocks while maintaining essential functions and safeguarding human rights. It encompasses social cohesion, institutional readiness, and individual empowerment.

Note: The goal is universally adaptable and open-access, enabling adoption without financial barriers.

SGG 6 is built on a four-part continuum for resilience.



This entire continuum is anchored in social equity and participation, expanding on global frameworks like Sendai and SDG 11.

Our advocacy will make resilience a shared responsibility and a lived reality.



Policy Integration & Governance Reform

Embed disaster preparedness into national development plans, urban policies, and social protection frameworks.



Community Empowerment & Education

Normalize preparedness through schools, workplaces, and grassroots campaigns led by WOSL Group.



Inclusive Planning & Equity Focus

Promote participatory planning processes where vulnerable groups shape local strategies.



Technology & Early-Warning Systems

Advocate for open-access, ethical, and multilingual digital tools led by DESA.

Principles that ensure commitment translates into action.

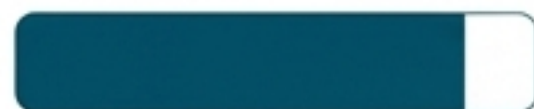

Fragmented Governance 	Clear institutional roles, cooperative charters, transparent reporting.
Technology Gaps 	Open-access tools, multilingual alerts, privacy safeguards.
Resource Strain 	Continuity planning, community networks, flexible governance.
