

THE MANDATE

A Constitutional Instrument


The Foundational Charter acts as the supreme 'Constitutional Instrument' of the Agenda 2074 Social Responsibility Standard (A2074-SRS). It is not a checklist, but a rights-preserving legal order that:

- Fixes the validation architecture.
- Affirms the 17 SGGs as the universal canon.
- Embeds Patient-Level Confidentiality as a structural right.



THE CANONICAL PILLARS

17 Non-Derogable Social Global Goals




Normative Integrity:

- **Traceability Mandatory:** All models (Stars, Points, Deep Dives) must map back to these pillars.
- **Canonical Integrity:** No pillar may be deleted, substituted, or obscured.
- **Interpretive Supremacy:** Defined strictly by the 'Rules for Interpretation' (Document 3).



THE PATIENT-LEVEL CONFIDENTIALITY PARADIGM


Private by Default. Disclosed only by Consent.




ADJUDICATION

Independence: Operates with ring-fenced financing and separate governance to insulate determinations from commercial pressure.



- Requirement: Reversible Aggregation (Traceable to Pillars)


